Some people say that registration ensures gun owners are accountable for their firearms and that the registry is an important tool used daily


by police to prevent and investigate crime. Others say that registering guns unduly burdens gun owners, is of no use and should be eliminated.



## Gun registry support has picked up steam: Canadian Press poll

OTTAWA - A new poll suggests public opinion was shifting in favour of keeping the controversial long-gun registry, even before the RCMP issued its favourable evaluation last month.

The late August poll by The Canadian Press Harris-Decima indicates that 48 per cent of respondents thought it would be a bad idea to get rid of the registry, up from 42 per cent in April and 41 per cent last November.


About 38 per cent thought it should be scrapped, down from 45 per cent in April and 46 per cent last November.

The shift in support for the registry came mainly among women, Ontarians and those earning between \$60,000 and \$100,000 a year.

The omnibus telephone poll of 1,000 people was conducted Aug. 26 to Aug. 29 — just before the Mounties released their analysis of the Canadian Firearms Program and said the registry should be maintained because it saves lives.

The survey has a margin of error of 3.1 percentage points, 19 times out of 20.






OTTAWA - Two-thirds of Canadians support the controversial longgun registry and even voters who back Prime Minister Stephen Harper's Conservatives are split on the issue, a new poll has found. The national survey conducted exclusively for Postmedia News and Global Television finds that support for the registry stands at 66% nationally. Moreover, support is strong in regions throughout the country — even though Harper has said his party will not "rest" until it abolishes the registry. But the poll also finds that although Harper is running counter to public opinion on the issue, his stance is only deepening his support among fervent Tories and that the NDP risks losing votes in the next election among Canadians unhappy with that party's internal divisions. [...] The survey, conducted Sept. 27 to Oct. 4, comes in the wake of a highly publicized parliamentary battle in which Conservative MP Candice Hoeppner failed in her effort to abolish the registry. The new poll finds that support for the registry is highest in Quebec (81%), followed by Ontario (66%) British Columbia (61%), Atlantic Canada (59%) and Saskatchewan/Manitoba (57%). In Alberta, the only place where the majority oppose the registry, the public is split — with half (53%) in opposition and the other half (47%) in support.

## Environics Research - Canada - 30 mars au 10 avril 2011



#### **NATIONAL POLL RESULTS**

The research is based on telephone interviews conducted with a representative sample of 2,000 Canadians (aged 18 plus), between March 30 and April 10, 2011. A sample of this size drawn from the population will provide results accurate to within plus or minus 2.2 percentage points, in 19 out of 20 samples.

#### **Deregulating Gun Ownership**

"As you may know, there are federal laws in Canada concerning the ownership of firearms. This law requires that Canadians register each firearm that they own, prohibits the ownership of certain kinds of firearms, requires that owners pass a safety test AND a safety check, and requires that firearms are stored unloaded in a secure place. "
